

## COLMEX PRO DISCOUNTED TRADING COMMISSIONS TERMS AND CONDITIONS

Colmex Pro Ltd (hereinafter called the “Company” or “Colmex Pro”) is a financial services Company incorporated and registered under the laws of the Republic of Cyprus under incorporation no. 260064, having its registered office at 117 Makariou III Avenue & Sissifou (ex Lefkosias-Limnazousas) Street, Quarter of Apostoloi Petrou & Pavlou, 3021 Limassol, Cyprus, (contact number + (357) 25-030036, Email: [support@colmexpro.com](mailto:support@colmexpro.com)). The company is licensed by the Cyprus Securities and Exchange Commission (“CySEC”), under license no. 123/10 to provide investment Services through its electronic system, via Internet.

Clients of the Company with an Equity trading account may trade commission free until a certain threshold is reached, by making a qualifying deposit and by accepting the present Terms and Conditions. Participation in this promotion (‘the promotion’) and eligibility for the discounted commissions are subject to the present Terms and Conditions, as well as the Company’s standardised [Terms and Conditions](#), which govern its contractual relationship with its clients.

### Terms of participation

- i. The promotion is available solely to new clients who open a new Colmex Pro Equity account on a Colmex Pro 2.0 platform and make a new deposit qualifying for the discounted trading commission, as described in section viii. of the promotion.
- ii. The promotion is only available to residents of Israel.
- iii. The promotion is restricted solely to clients who open a new account with the platform Colmex Pro 2.0.
- iv. The promotion is active and valid from 24/08/2021 until 24/09/2021.
- v. It is hereby clarified that the opening of a trading account with the Company is subject to the Company’s registration process and internal procedures, including successfully passing the Company’s appropriateness test, being within the Company’s positive target market and being approved as the Company’s client.
- vi. Only clients who accepted the present Terms and Conditions will be eligible this promotion.
- vii. The minimum qualifying deposit is \$3,000 and the corresponding trading commission discount is \$300.
- viii. Internal transfers from an old platform to the new platform does not qualify as a deposit and therefore does not grant the client with \$300 free trading commission.
- ix. The client will not be charged any trading commissions until reaching the amount of the trading commission discount in the amount of \$300 and realizing the full discount.
- x. The benefit will lapse on 31 December, 2021, clients will not be able trade commission free through this promotion after the said date.
- xi. The Commission applicable to the client’s trading account will be calculated based on the clients’ trading plan as of the day of qualifying deposit and will remain the same until the total amount of applicable trading commission amount is reached.
